Frogans addresses: New identifiers for Frogans sites

10 linguistic categories covering 170+ languages

Network-name*Site-name

Latin

اسم-شبكة*اسم-موقع

Arabic

网络 - 名称 * 现场 - 名称

Chinese

שם-רשת*שם-אתר

Hebrew

Сеть-название*Сайт-название

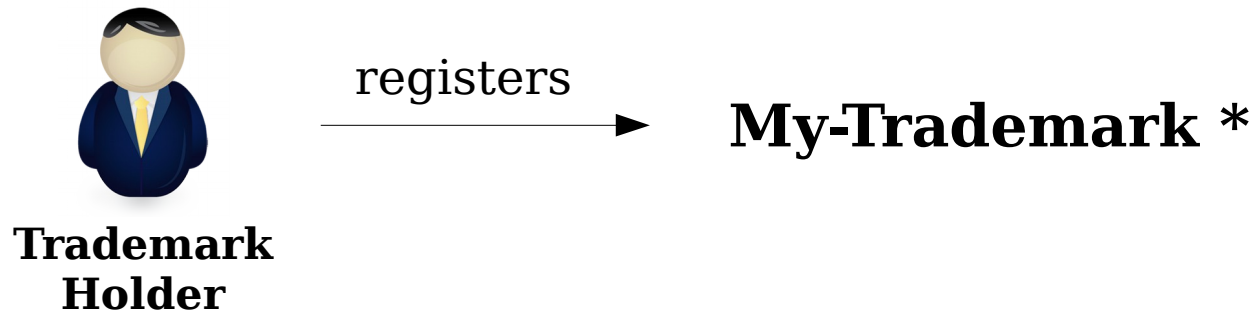
Cyrillic

- Frogans addresses are not domain names
- Frogans addresses are used to identify Frogans sites on the Internet
- A Frogans adress belongs to a Frogans network

Registration of Dedicated Frogans Networks during this period

**Only Trademarks can be registered as
Dedicated Frogans Network during this priority period**



Launch Date: April 15, 2015

Which trademarks are allowed?

ACCEPTED TRADEMARKS

Registered trademarks
International office (WIPO)
Regional office (e.g. OHIM)
National office (e.g. INPI for France)

Marks validated by a court
decision
(e.g. Unregistered “Common
Law” mark or well-known mark)

Marks protected by
a statute or a treaty
(e.g. geographical indication or a
designation of origin)

REFUSED TRADEMARKS

Figurative or sounds
trademarks

Unregistered trademark

Trademarks registered
with local offices or with
offices of federated states

Canceled, opposed,
invalidated, corrected
trademarks

Trademarks which have not
been definitively registered

**IF INACCURATE, FALSE DECLARATION
OR FAILURE TO PROVIDE THE REQUESTED DOCUMENTS**

- Infringement of the Frogans Technology User Policy (FTUP)
- Possible cancellation of your registration
