Frogans addresses: New identifiers for Frogans sites

10 linguistic categories covering 170+ languages

Network-name*Site-name

Latin

اسم-شبكة*اسم-موقع

Arabic

网络 - 名称 * 现场 - 名称

Chinese

שם-רשת*שם-אתר

Hebrew

Сеть-название*Сайт-название

Cyrillic

+ Japanese, Korean,
Devanagari, Thai, Greek

- Frogans addresses are not domain names
- Frogans addresses are used to identify Frogans sites on the Internet
- A new addressing system on the Internet requires a specific UDRP: UDRP-F

What are the differences with the UDRP?

Domain name → Network Name or Site Name

Web site → Frogans site

ICANN → OP3FT

Registrar → FCR account administrator
(Frogans addresses registration)

Registrar → FCR Operator
(UDRP-F decisions implementation)

- Simple procedure for resolving disputes concerning Frogans addresses

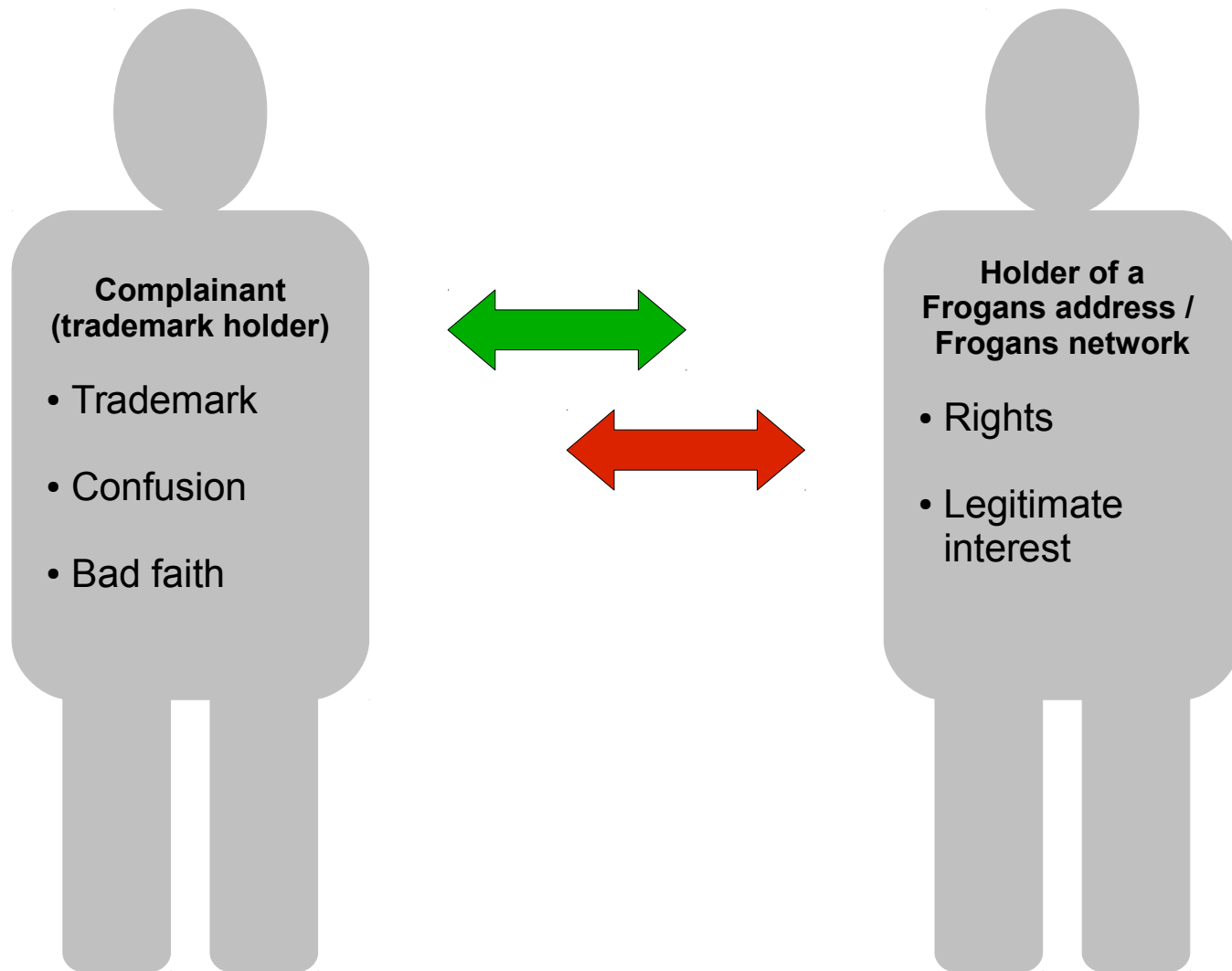

How to file and how to respond to a UDRP-F claim?

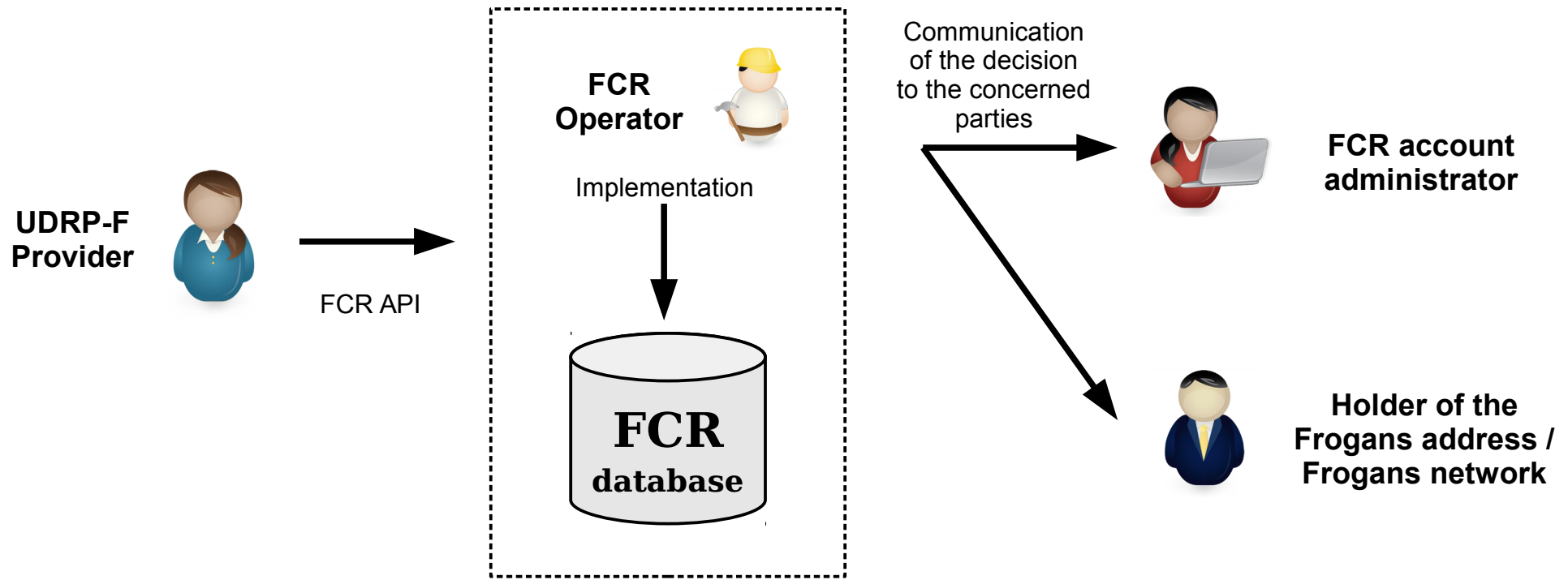


What are the available remedies?

Applicable disputes	Arbitration	Available remedies
frogans* Site-name فروجنز*موقع-اسم		Cancellation or transfer of the Site Name registration
Network-name *Site-name 网络-名称*现场-名称		Cancellation or transfer of the Network Name registration
Network-name* Site-name Сеть-название* Сайт-название		Cancellation of the Site Name registration

- Three types of registration; three types of remedy
- Language of proceedings can correspond to linguistic category of the registration
- UDRP-F concerns both parts of Frogans addresses

How are UDRP-F decisions enforced?



- Access to the FCR API is exclusively reserved for UDRP-F providers
- Decisions are implemented by the FCR Operator
- Implementation date of the decision is communicated by the FCR Operator
